Rental Policies

A \$50 down payment is due to secure a reservation. This money will count towards the total of your bill and will only be refunded if the party is cancelled due to weather and cannot be rescheduled. Once you have been contacted and a date has been approved, final payment of the party is due at least one week prior to the scheduled date.

- Parties must be scheduled a minimum of two weeks in advance.
- Parties may be cancelled due to inclement weather at the discretion of the Oasis Manager.
- If the Oasis closes due to inclement weather, the party will be rescheduled at no additional charge; time permitting.
- Alcohol is prohibited.
- **Outside food is prohibited** with exception of cake/cupcakes and ice cream.
- Renter is responsible for making all guests aware of Oasis rules.

Information/Warning of Risk/Waiver and Release

I agree that myself and my guests will abide by all rules and regulations set by the Bloomingdale Park District, written or unwritten. I, as the renter assume all responsibility for any damage to Bloomingdale Park District property during our use of The Oasis.

Information:

The (Bloomingdale Park District) "Park District" is committed to providing safe aquatic facilities and programs and holds the safety of participants in high regard. The Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors engaged in aquatic activities must recognize that there is an inherent risk of injury.

You are solely responsible for determining if you or your minor child/ward is physically fit and/or adequately skilled for the activities associated with this rental. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical/aquatic activity.

Please understand and recognize that lifeguards are not responsible for providing supervision or assessing your swimming skills or that of your minor child; rather, lifeguards are responsible for enforcing safety rules and responding to emergencies. Adults and parents of minors are solely responsible for supervision of any and all activities contemplated by this agreement.

Warning of Risk:

Swimming is a sport which challenges and engages the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including but not limited to drowning, head/brain injury, and cervical spine injury. Understandably, not all hazards and dangers

can be foreseen. The very nature of swimming is hazardous and risky, including but not limited to fatigue and overexertion, poor swimming skills, failing to avoid dangerous areas, horseplay, diving or cannon-balling into shallow water and striking the bottom or side of the pool, poor supervision or instruction, lack of conditioning, becoming disoriented, striking other swimmers, defective or inadequate equipment, striking one's head on the bottom when using a diving block, slipping or falling on the deck or within the locker facility, chemical exposure and all other circumstances inherent to the sport of swimming. In this regard, it must be recognized that it is impossible for the Bloomingdale Park District to guarantee absolute safety.

Waiver and Release of All Claims and Assumptions of Risk

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity (including transportation services, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program, and I voluntarily agree to assume the full risk of any injuries, damages, or loss, regardless of severity that my minor child/ward or I may sustain as a result of participating in any and all activities connected with or associated with this program/activity. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the Bloomingdale Park District, including its officials, agents, volunteers and employees.
